TERMS AND CONDITIONS OF SALE/SHIPMENT AND USE

ALL ORDERS ARE ACCEPTED AND ALL SALES ARE EXPRESSLY MADE CONDITIONAL ON PURCHASER'S AGREEMENT TO THE TERMS AND CONDITIONS SET FORTH, NOTWITHSTANDING ANY PURCHASE ORDERS OR OFFERS TO PURCHASE CONTAINING DIFFERENT OR ADDITIONAL PROVISIONS. PURCHASER'S ACCEPTANCE OF THE GOODS CONSTITUTES ACCEPTANCE OF THESE TERMS AND CONDITIONS AND ALSO PURCHASER'S AGREEMENT THAT THEY CONTROL OVER ANY TERMS, CORRESPONDENCE OR FORMS SUPPLIED BY PURCHASER AT ANY STAGE OF THE TRANSACTION.

ACCEPTANCE AND CANCELLATION OF ORDERS. Seller may cancel the order, or require full or partial payment in advance of shipment or preparation, if the financial condition of the Purchaser is not satisfactory to the Seller at the time shipment is ready, or at any other time. After acceptance, orders cannot be cancelled by Purchaser without Seller's written consent. All orders are accepted and all sales are made subject only to these Terms and Conditions as a final, complete and exclusive statement of the parties' agreement. No statements, representations, agreements, or changes of any kind or any conflicting terms or conditions incorporated in any writing by Purchaser to Seller are binding on Seller unless specifically agreed to in writing by Seller. Any and all prior statements, representations, and agreements not incorporated herein are excluded and superseded hereby. No course of prior dealings between Seller and Purchaser and no usage of trade shall be used to supplement any term used in this agreement. Acceptance or acquiescence in a course of performance rendered under this agreement shall not be relevant to alter the meaning of this agreement. MODIFICATIONS MUST BE IN WRITING. These Terms and Conditions shall not be modified or rescinded by agreement or conduct or waived unless specifically agreed to in writing by Seller's duly authorized representative.

QUOTATIONS/PRICES/TAXES. After Seller's acceptance of an order, Purchaser's attempted modifications shall not be effective unless accepted in writing by Seller. Acceptance may be conditioned upon Purchaser's acceptance of intervening price changes related to such modifications. The amount of any present and future sales, use, excise, or similar taxes, applicable to the ordered goods shall be added to the Seller's price and paid by the Purchaser, unless the Purchaser timely provides Seller with a tax exemption certificate applicable to Seller.

PRODUCT MODIFICATIONS AND SUBSTITUTIONS. Seller reserves the right to change or modify at any time any product or any materials used in the fabrication of products, or to discontinue the manufacture of any product, without liability with respect thereto.

SHIPMENT AND DELIVERY. Seller reserves the right to make partial shipments. Pro-rata payments become due as partial shipments are made. Seller shall not be liable for any penalty or damages, liquidated or otherwise, for shipment or deliveries which are delayed due to any reason whatsoever. Seller shall not be liable for any loss or damage caused by factors beyond its ability to control, including (without limitation) changes in government regulations or acts of God, Purchaser's acts or omissions, labor shortages, strikes, slowdowns or other combined action or workmen, fires, floods, earthquakes, severe weather, serious accident, epidemics, quarantines, wars, insurrections or riots, acts of civil or military authorities, transportation embargoes, shortages or interruptions, deliveries of components and materials, and delays by Seller's suppliers. Claims for shortages or non-conforming shipments must be made in writing and sent to Seller immediately upon Purchaser's receipt of the shipment. Failure to give such notice shall be deemed unqualified acceptance and a waiver by the Purchaser of any claim with respect to the Shipment.

DAMAGED OR LOST SHIPMENTS. Goods are shipped F.O.B. shipping point only. When goods have been delivered to a carrier for shipment, the risk of loss passes to Purchaser and Seller's responsibility for delivery ends, but Seller agrees to furnish duplicate bills of lading and otherwise render reasonable assistance in making claims for damages against the carrier. Shipment should be examined carefully before being accepted from the carrier. Seller assumes no responsibility for damage after having received "in good order" receipts from a carrier at shipping point and all loss, damage and delay in transit are at the risk of the Purchaser.

RETURNS. Unless its permission has been first obtained, Seller will not accept goods for return or credit, other than for claimed warranty. Risk of loss for returned goods will remain with Purchaser and Purchaser shall reimburse Seller for any cost it incurs in connection with the shipment and return of the goods. Non stock products fabricated to order are not returnable under any circumstances except for approved warranty claim.

TERMS IN EVENT OF NON-PAYMENT. Interest at the maximum legal rate established from time to time, or 18% per year, whichever is lower, shall be charged on overdue accounts. If an invoice is not paid when due, or it becomes necessary for Seller to enforce any of these terms and conditions, Purchaser agrees to pay all costs of the collection, or enforcement or both, including attorney's fees, whether incurred in or out of court, or appeal, in arbitration, in a bankruptcy proceeding, or in any insolvency proceedings.

PENALTY CLAUSES. Seller assumes no liability arising from penalty or liquidated damage clauses of any kind, written or implied, unless specifically approved in writing by Seller's duly authorized representative.

LIMITED WARRANTY/SOLE REMEDY. Seller warrants that its goods shall conform to the applicable CSA or ASTM standards and shall be free from defect in material or workmanship for one year. PVC goods are warranted only for use in accordance with ASTM D-2321 and Unibell PVC Pipe Association Recommended Practices for Installation of PVC Sewer Pipe or other applicable installation standard. Seller will, at its option, repair, replace or issue credit for the purchase price of any goods proven to be non-conforming. Repair or replacement of the goods as described, or return for credit at Seller's option, shall be Purchaser's sole and exclusive remedy for any defect. SELLER'S OBLIGATION IS LIMITED TO THE PURCHASE PRICE OF THE GOODS AND COST OF TRANSPORT.

In the Event the Goods Sold to Purchaser Fail to Conform to the Limited Warranty Referred to Herein, Purchaser must Give Seller Written Notice of Such Nonconformance Within 30 Days of the Time of Discovery of the Defect or the Time When the Defect Should Have Been Discovered, and Within One Year of Receipt of the Goods, or Purchaser Waives Any Right with Respect to the Goods. WITHIN A REASONABLE TIME AFTER WRITTEN NOTICE, AND PURCHASER'S RETURN OF THE DEFECTIVE GOODS TO SELLER, SELLER WILL REPLACE THE DEFECTIVE GOODS OR, IN SELLER'S SOLE DISCRETION, REFUND THE PURCHASE PRICE OF SUCH PORTION OF THE GOODS AS ARE RENDERED UNUSABLE AS A RESULT OF SUCH DEFECT. PURCHASER AGREES THAT THIS IS THE SOLE AND EXCLUSIVE REMEDY OF THE PURCHASER WITH RESPECT TO THE GOODS. SELLER'S ENTIRE LIABILITY ON ANY CLAIM ARISING OUT OF THE SALE OF GOODS OR ITS REPLACEMENT OF DEFECTIVE GOODS, WHETHER IN CONTRACT, WARRANTY, TORT OR OTHERWISE, SHALL BE LIMITED TO THE PURCHASE PRICE OF THE GOODS THAT ARE PROVEN DEFECTIVE AND COST OF TRANSPORT. THIS WARRANTY DOES NOT EXTEND TO, AND IS VOIDED BY, GOODS DAMAGED OR FAILED BECAUSE OF, OR BY USE WITH, MATERIALS OR SUPPLIES OR METHODS NOT APPROVED BY GPK PRODUCTS, INC. OR ASTM D-2321 OR OTHER APPLICABLE INSTALLATION STANDARD; MISUSE; ABUSE; ACCIDENT DAMAGE IN TRANSIT; IMPROPER HANDLING OR INSTALLATION NOT IN ACCORDANCE WITH RECOMMENDED PRACTICES; OR THEIR CONSEQUENCES.

SELLER SHALL NOT BE LIABLE FOR ANY DAMAGES, DIRECT, INCIDENTAL, SPECIAL, INDIRECT OR CONSEQUENTIAL, WHETHER RESULTING FROM SELLER'S NEGLIGENCE OR OTHERWISE, ARISING OUT OF, IN CONNECTION WITH, OR RESULTING FROM THE GOODS SOLD TO THE PURCHASER, NOR FOR ANY CLAIMS, ACTIONS, SUITS AND PROCEEDINGS WHICH MAY BE INSTITUTED IN RESPECT TO THE FOREGOING, INCLUDING THOSE MADE BY SUBSEQUENT OWNERS AND USERS OF THE GOODS, NOR FOR STRICT LIABILITY OR OTHER TORT, NOR FOR LOSS REVENUES OR EARNINGS, LOST PROFITS, LOST OPPORTUNITIES, COSTS OR DELAYS, LOST GOOD WILL OR REPUTATION, OR PUNITIVE OR EXEMPLARY DAMAGES. CONDITIONS OF RESALE/SUBSEQUENT PURCHASES. These Terms and Conditions shall be binding upon Purchaser and all subsequent owners and users of these goods.
